## TERMS AND CONDITIONS OF DEFERRED FEE AUTHORIZATION

### ELIGIBILITY:

1. A good credit history at Kenai Peninsula College
2. An identifiable means of making timely payments

### TERMS:

- 1: The initial payment is due PRIOR to the 1<sup>st</sup> day of Semester
- 2: Remaining payments are due on or before the dates indicated

### DROP/WITHDRAWL:

If you DROP/WITHDRAW from any course for which this loan is made, notification in writing (ADD/DROP form) **MUST** be completed and processed by KPC. The refund policy is listed in the current Course Bulletin and Class Schedule.

If you DROP from a class during the refund period, any refund due will be applied to your balance. The remaining balance, if any, will still be due.

If you fail to formally **DROP** the class in a timely manner, you are still responsible for payment in full for the classes you registered for.

### DELINQUENCIES:

Kenai Peninsula College reserves the right to withhold transcripts, diplomas, or final grade reports from you if you have not paid all of your financial obligations. Your account must be paid in full prior to any further registration activity.
